#### PRIVACY POLICY

#### (**Updated June 6, 2016**)

A private entity owns, runs and operates this web site ("Web Site"). This Privacy Policy explains what information is collected on this Web Site, how the private entity that operates and owns this Web Site uses your information, and your choices. This Privacy Policy only covers information collected at this Web Site and other web sites operated by the private entity that operates and owns this Web Site where this Privacy Policy is posted, and does not cover any information collected offline or elsewhere by the private entity that operates and owns this Web Site or any other company. Please read this Privacy Policy carefully. In addition, please review the Terms of Use, which govern your use of this Web Site. ## **Information Collected Through This Web Site**

### **Personally Identifiable Information:**

The private entity that operates and owns this Web Site may ask you to provide personally identifiable information about yourself at various times and at various places on this Web Site, such as when you register for newsletters, subscribe for home delivery, or choose to participate in a contest, sweepstakes, survey or other feature on the Web Site. #### **Non-Personally Identifiable Information:**

When you visit this Web Site, the servers automatically collect certain web site usage information. #### **Third Party Content**

When you are on this Web Site, certain content may be served by a third party. #### Use by this Web Site:
